Fitness Center Rules and Instructions

Access Keys- Must only be used by assigned user. Assigned user is responsible for any damages caused by anyone using their access key. If key is lost or stolen, it must be reported immediately to the gym. Replacement keys are \$20. Key must be turned in at the end of membership, if key fee is waived at sign up.

Dress Code – Please wear appropriate athletic shoes and shirts all times. Tank tops are considered appropriate. NO blue jeans on fitness equipment. Men must wear shirts.

Center Usage for Children – Children under 14 years of age must be accompanied by their parent or responsible adult and may only use facility under the direct supervision of the adult. The guardian of the child will take full responsibility for the child and the center may refuse usage for children if necessary due to safety or unruliness of the child.

Guest Pass – Identification must be shown and guest must sign a liability release. Guest passes are redeemable for one day and purchased for \$5.00

Equipment Usage – seek staff assistance before using any equipment for the first time or if unsure as to how to use the equipment. Follow the guidelines of any signs posted in the facility. Return any free weights you have used to the rack when finished. Fitness Center is not liable for any lost or stolen item.

Payment – Monthly dues +sales tax must be paid upon joining fitness center and thereafter according to membership term agreement. Should you default on any payment obligation as called for in the agreement, the Fitness Center will have the right to declare the entire remaining balance due and payable. A default occurs when any payment is over 15 days late.

Member Obligation – Member must abide by all Fitness Center policies, follow the directions of the staff regarding safety and security issues, and to treat the staff and other members of the center with courtesy. Member must agree to pay monthly dues on time, including notifying the Center promptly if banking or credit card information used for automatic payment changes. Member must adhere to security policies and may not bring guests during non staff hours.

Termination of Contract – Upon completion of the membership term, Fitness Center will automatically renew contract unless canceled by the member. Member may cancel contract only in the event of moving or a catastrophic event occurs, ie..loss of job. You may cancel a month to month contract as long as notice is given 15 days in advance before next payment is due.
